# PRECAUTIONARY WATER BOIL NOTICE AND WATER SERVICE INTERUPPTION

RESISDENTS OF CENTURY, FLORIDA, LIVING ON PLEASANT HILL ROAD, JUNK ROAD, FIELDS ROAD, CARTER LANE, NALL ROAD, AND WEST HIGHWAY 4 EAST OF NALL ROAD TO WILLIAMS STREET, BUT NOT INCLUDING WILLIAMS STREET.

Central Water Works will be conducting necessary repairs tomorrow, Wednesday, June 4th, from 8:00 a.m. to 4:00 p.m. As a result, the residents listed above's water service will be temporarily interrupted

Following the service interruption, a precautionary boil water notice will be in effect. Central Water Works will notify customers directly when the boil water notice has been lifted.

#### What should I do?

As a precaution we advise that all water used for drinking, cooking, brushing teeth, or washing dishes be boiled. A rolling boil for one minute is sufficient. Or residents can disinfect water by adding 8 drops (1/8 teaspoon) of common household bleach(unscented) to water; stir; let it rest for 30 minutes before drinking. Residents are also advised to take precautions when bathing, especially immune-compromised individuals, infants, and elderly.

# What happened?

A leak was discovered on W Hwy 4. When service is completely stopped, or when a loss of sufficient water pressure occurs, this could cause back siphonage of contaminants, such as e. Coli bacteria, into the water system. Water containing e. Coli bacteria can be considered safe for drinking and cooking after vigorously boiling the water. Disease symptoms caused by these bacteria may include diarrhea, cramps, nausea, and possible jaundice, and any associated headache and fatigue. EPA has set an enforceable drinking water standard for e Coli to reduce the risk of these adverse health effects. Under this standard all drinking water must be free of these bacteria.

### What is being done?

The damaged water main will be repaired beginning in the morning on Wednesday, June 4, 2025. After the repairs are complete, Central Water Works will collect samples to determine if the presence of e. Coli bacteria exists within the water system. This precautionary boil water notice will remain in effect until bacteriological survey shows the water is safe to drink. Residents will be notified by phone, email or text.
